


## Q1: What is your top concern(s) at these locations?



### Responses: 7 Total/1 Skipped


- Conflict with property owns and proper maintenance

### Responses: 7 Total/0 Skipped


- Safer travel and comfort in knowing snow and mud won't be such a big issue leaving our homes during bad weather, especially important for emergencies and medical appointments.

### **Overall Summary**

The Virtual Workshop 2 gained valuable community feedback for the Cahuilla LRTP project through the online breakout sessions and surveys provided on the project website. The breakout survey questions asked for input on the priority projects in the three focus areas and recommended design concepts for SR-371, Pedestrian and Bicycle Facililities and the Internal Roads. There were 14 total responses received from the survey with a majority of the responses being positive. Responses included feedback on the preference of design concepts, future concerns and questions about next steps. The responses were supportive of the project, the process and future transportation improvements included in the long-range transportation plan.
